



Fees and Financial Assistance

We have two types of fees here at ATI.

Professional Fees, which are paid by all Year 1 and Year 2 students. These cover your registration, exams, course textbooks and other learning and learner supports available.

Tuition Fees, these are paid by Year 1 and Year 2 learners studying directly with us through the ATI Academy Online programme. The tuition fees cover each of the four modules and associated tutorials, lectures and e-learning resources.

Students wishing to study with one of our partner colleges will pay tuition fees directly to the college upon registering. Once you have secured your place, you can register via our website to pay your professional fees and to receive your ATI student registration number. It is this number which is used for your exams and to access your student TouchPoint portal.

We offer a **stepped payment option** for both our professional fee and tuition fees. You will need to select this at the point of registration if you wish to avail of it.

ATI Academy Online programme Fees

Students studying with our Academy Online programme pay both their professional and tuition fees directly to ATI.

Additional Fees (ROI and NI)

The Diploma is conferred on the successful completion of two years of study and two years of relevant work experience within an accounting or finance environment. The work experience is assessed via the Work Practice Programme, which can be completed either during study or upon completion of the 8 academic modules.

Financial Assistance

To make the Diploma qualification as accessible to as many as possible, financial education assistance is available for eligible students, in the Republic of Ireland and Northern Ireland, studying with partner colleges. You will need to secure this independently of ATI.

Once approved, we will facilitate funding through employers, government grants such as TESS and BTEA, the Skills to Advance and Skills to Compete initiatives through FETCH and through Student Finance NI.

Membership fees (ROI and NI)

Once a student successfully completes their two years of study, they become an Affiliate Member until they complete the required work experience.

If a student completes both their two years of study and two years of work experience (assessed via the Work Practice Programme), they are invited to graduate and will be conferred with Full Membership of the Institute, receiving the MIATI designation at our annual Conferring Ceremony, which takes place every February.
